CALL TO ORDER

The meeting was called to order by President Debbie Arnold at 9:00 A.M. followed by introductions of directors, staff and guests.

INTERNAL OPERATIONS BUDGET

- Internal Operations Budget Report
 - o Balance of cash in bank as of March 21, 2018 \$46,637

<u>It was moved, seconded and approved to accept the Internal Operations Budget Report</u> for the San Luis Obispo County Community FireSafe Council as presented

GENERAL BUSINESS

- Santa Rita Templeton residents met with CAL FIRE / San Luis Obispo County Fire to ascertain how they can receive funding for fire prevention work in their area. It was recommended they get organized with the infrastructure and form a focus group. Once that happens they can seek recognition from the FireSafe Council as a focus group which will give afford them opportunities with available grants.
- Changes in Fire Wise Community requirements has created frustration and confusion in those communities. The guideline was that \$2 per person in the community was to be spent on wildlife risk reductions annually. The new guideline states that \$24 per dwelling in the community must be spent. Clarification on the rule is that \$24 equates to one hour of volunteer time per dwelling unit for mitigation annually. The rate (\$24) is based on the 2017 annual National Hourly Volunteer Rate.
- Senator Monning's legislation (SB1079) authorizing advance payments for the forest health grants and the fire prevention fund grant programs is progressing through the process. It has been submitted as an urgency measure which will make it effective immediately upon approval. Letters of support are encouraged from all groups and agencies. A template will be emailed to all SLO FSC members.

 - o Countywide HFR Non SRA \$68,200 awarded, \$0 expended

- Bill Robeson, Director of Public Works, for the City of Arroyo Grande and Chief Steve Lieberman, Five Cities Fire Authority, presented a request for assistance for the James Way open space area. The area is approximately 40 acres and is very over grown. The City does not have the manpower, equipment or the financial resources to ensure adequate defensible space for the residences in this area. They were granted immediate financial assistance in an amount not to exceed \$6,000. Dan Turner, Business Manager, will work with them to prepare a scope of work and assist them with grant information to obtain future funding.
- The City of Atascadero will have a City wide chipping event. Dan Turner has been directed to work with Atascadero to coordinate funding.
- Los Osos will host curbside and drop-off chipping for residents in May. Funding was approved for this event at the Executive Committee meeting of February 21, 2018.
- o CWPP & WUI Plans Non SRA\$67,100 awarded, \$0 expended
 - Bob Neumann will investigate the updating and printing costs for the "Living with Fire" brochure.
 - Direction was given to Dan Turner, Business Manager, to collaborate with Chris Elms, CAL FIRE, on purchasing items for the Mid-State Fair. These purchases are not to exceed \$5,000.
- 15-SRA Countywide Hazard Fuel Reduction \$98,758 awarded, project complete pending processing of outstanding \$7,145 invoice.

- PG&E Hazardous Fuel Reduction grants
 - o Four projects were submitted.
 - o Two pieces of equipment were requested.
 - Remote control chipper
 - Terra torch
 - Direction was given for any available board members to attend the worksite of CAL FIRE when they are renting the remote control chipper. Those attending the demonstration are directed to review and advise Dan Turner on their findings and recommendations. Mr. Turner has been directed to assess both pieces of equipment and act accordingly. If grants are awarded to purchase equipment, the equipment may be donated to SLO County Fire to keep with tradition of SLO FSC not owning equipment. Consensus is it would be better to lease the equipment instead of purchasing it so no maintenance or repairs will have to be paid for by SLO FSC.
- 2018 CA Fire Safe Council Clearinghouse Grants
 - o Application period opens April 3, 2018, open to both SRA and non-SRA areas
 - o \$4.1 million in State Fire Assistance grants
 - o \$1.3 Million in tree mortality grants
 - o Grant committee will make recommendations
